

Application for Zoning Change

THE FOLLOWING ITEMS MUST BE FILED WITH THIS APPLICATION

- 1. FILING FEE OF \$50.00 PAYABLE TO THE CITY OF BRAZIL.
- 2. Ruling or order from Planning Administrator on which application is based (letter form).
- 3. Plat plan showing plots of land and structures or improvements thereon surrounding plot of land affected, extending at least one (1) city block or 660' in each direction.
- 4. Plot plan in duplicate, drawn to scale showing the lots or plot, existing structures, the proposed location of the building or buildings on the plot, the location of the right of way line or lines of adjoining highways, streets or alleys and the proposed location of sewage disposal system.
- 5. Plans for the proposed structure(s) that must include floor plan and elevations, if applicable.

Petitions for change of zoning regulations and all required documents must be filed at least **fifteen (15) days** prior to date of next regular meeting of the Brazil Advisory Planning Commission.

All petitions for change of zoning regulations shall be on forms provided by the Department of Planning and Zoning. Until then, the Commission has no jurisdiction.

A public hearing, as prescribed by law, requires one insertion of legal advertisement, in the form designated by the Commission, in a newspaper of general circulation in the City of Brazil, Indiana at least ten (10) days prior to the date of hearing. Notices to adjoining property shall be served by the petitioner at least five (5) days prior to date of hearing by registered mail. Before this petition can be called at said hearing, an affidavit shall be made and filed by the petitioner stating that all necessary notices have been given as required by the Plan Commission.

This application must be accompanied by the information specified on the previous page, and filed by the legal owners of fifty (50) percent or more of the real estate in the area involved in this petition at least **fifteen (15) days** prior to date of the public hearing by the Brazil Advisory Planning Commission.
